PLEASE TAKE NOTICE that immediately following a public hearing on the matter, a proposed resolution(s) will be considered by the Governing Board of Culver City Unified School District at its regular meeting on May 24, 2022, at 6:00 p.m., which if adopted by the Board will implement development fees established by the District against residential construction and reconstruction at \$4.79 per square foot and against new commercial or industrial construction at \$0.78 a square foot. Education Code Section 17620 and Government Code Section 65995 authorize the proposed fees.
